IMPORTANT - TRANSFERS of dogs from regular classes to Best of Breed/Variety Competition (Ch. 11 Section 6, AKC Rules) MUST be made to the Superintendent/Show Secretary at least one half hour prior to the start of any regular conformation judging at this show. TRANSFERS by Junior Handlers from Novice to Open Class or from the Open to Master Class MUST be made to the Superintendent/Show Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging at the show. SUBSTITUTIONS of Junior Showmanship dogs must be made at least one half hour prior to the judging of any Junior Showmanship classes at the show.

AKC National Owner-Handled Series

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show.** Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. **A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotti Romagnoli, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirnecchi dell'Etna, Grand Basset Griffon Vendeens, Standard Schnauzers, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Entlebucher Mountain Dogs, Finnish Lapphunds, Icelandic Sheepdogs, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs and Norrbottenspets (Misc.).

At the discretion of the judge, the following breed may be judged on a table or on a ramp through all levels of competition including Group and Best in Show judging: Mudik (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

NOTICE

*Juniors who win a third Novice Class with competition present, after the closing of entries for a show, **ARE REQUIRED TO TRANSFER** their entry from the Novice Class to the Open Class **BY NOTIFYING** the Superintendent or Show Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging at the show.*

Dogs May Arrive any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

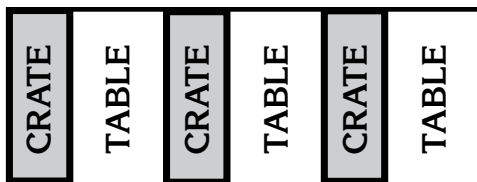

LAYOUT REQUIREMENTS FOR EACH DAY



The grooming layout in the East Hall will be as described and all exhibitors in the East Hall must conform to the guidelines to enhance the experience for all exhibitors. Please cooperate with the Show Committees to enhance this show experience for all exhibitors. The West Hall host grooming in a "bull pen" configuration as in the past.

The layout plan shows that all grooming areas are to be laid out in a straight line manner with a row of crates on the left and a row of tables on the right. The crate row is 3 feet wide and the table row is 6 feet wide.

Crates doors are to face the tables. Tables are to be set lengthwise in the center so that the aisle is free for traffic to walk through. In areas where tables are not used, crates may be set up on both sides, but they must not block the traffic in the aisle.

- There will be no saving of space for exhibitors who are to arrive later.
- Some space is reserved by the cluster clubs for breeds holding a specialty.
- Rugs, carpets, furniture, grooming pens are not allowed in the setup area.
- Folding chairs are allowed, but they cannot take the place of a table or crate. Chairs must be folded and put away when not in use. Aisles must be kept clear. If you are blocking an aisle when using the chair, please move the chair and stand aside for traffic to move through.
- We may require hard crates and wire crates (size 300 & smaller) to be stacked if required to accommodate all exhibitors.

Please cooperate with our volunteers. They are trying to help all of us share the space. They will have full support of the show giving clubs, including the ability to call for an event hearing.

RV Parking at the Coliseum ***Reservations Required for Electrical Hookup*** **Parking Information**

RESERVATIONS ARE ONLY TAKEN FOR THREE DAY RV PARKING. Less than three day parking will be handled by Coliseum personnel and electrical will be on an "as available" basis. If you are in the Gate City Blvd. RV lot you will be furnished, at no additional charge, a parking pass for access to the lot adjacent to the show building. The fee for the entire Cluster is **\$125.00** and includes electrical and parking fees. Two days or less parking with electrical is \$45.00 per day. Access to water is available but NO permanent water hookups are permitted. There are no sewer hookups. All units must be self contained.

Hotel/Motel Regulations

NOTICE TO DOG OWNERS/EXHIBITORS

THE FOLLOWING RULES HAVE BEEN ESTABLISHED FOR THE GOOD OF ALL EXHIBITORS CONCERNED. Failure to comply could result in an event committee action (Chapter 5, Section 2 of "Rules Applying To Registration And Discipline").

1. Plastic sheeting is to be placed under every crate in hotel rooms. This will keep carpets clean and dry. Plastic sheeting for each crate will be the responsibility of each exhibitor to provide their own.
2. DOGS MUST BE CRATED WHEN OWNER IS OUT OF THE ROOM. NO EXCEPTIONS.
3. DOGS MUST BE KEPT ON LEASH AT ALL TIMES WHILE IN THE HOTEL, LOBBIES, OR ON HOTEL GROUNDS. ROOMS AND LOBBY MUST BE KEPT CLEAN OF DOG DEBRIS.
4. Dogs should be "exercised" in designated areas on motel premises. Every dog owner is expected to pick up after his own dog and dispose of waste in designated trash cans. It is the responsibility of the dog owner to find out from the innkeeper where these areas and cans are.
5. No dog may be bathed in the hotel due to severe clogging problems in the drain pipes.
6. Rooms will be inspected daily by members of the hotel staff and observed violations or damages will be reported to the hotel management and/or the Investigative Committee.
7. The Investigative Committee, working with a fair and equitable system, is charged with investigating complaints.
8. Each dog owner/registrant is expected to cooperate with the Investigative Committee, hopefully settling damage claims on the spot, or else must be willing to furnish information such as Insurance policy numbers and other required pertinent information.
9. Should a hotel/motel for cause, deem it necessary to cancel room privileges, the registrant agrees to forego legal actions against the clubs, MB-F, Inc., and the hotel/motel.
10. As an exhibitor, I am aware that violations may also be referred to the Event Committee if written charges are preferred. If such charges are upheld by the Event Committee, it may lead to suspension from future show privileges.
11. Limit one (1) dog per room, OR AT THE DISCRETION OF THE INNKEEPER.

I-85 SOUTH/I-40 WEST FROM BURLINGTON: From I-40 West take Exit 131 to I-40 Business West. Follow I-40 Business West (7.5 miles) to Exit 36-A, I-40 Business West. Follow I-40 Business West (1 mile) to Exit 218B, Freeman Mill Rd. Go .3 mile and turn left on Coliseum Blvd. One mile to the Complex on your left, turn left onto Ellington St. and right into the main entrance.

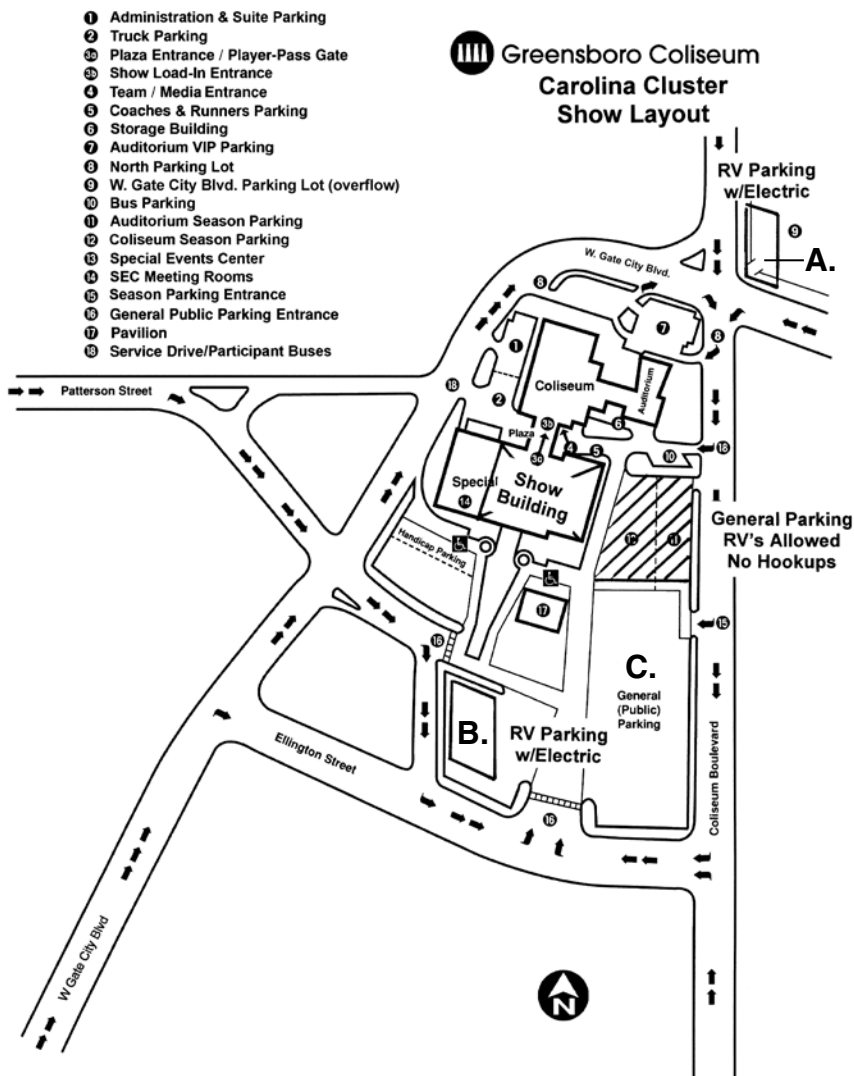
I-85 NORTH FROM CHARLOTTE: On I-85 North from Charlotte, take Exit 120-A to access I-85 Business North. Continue 2 miles to Exit 35-B Highway US 220 North. Proceed 1.8 miles and turn left on Coliseum Blvd. One mile to the Complex on your left, turn left onto Ellington St. and right into the main entrance.

I-40 EAST FROM WINSTON-SALEM: On I-40 East from Winston-Salem, take Exit 212 to I-40 Business East. *Continue 3.5 miles on I-40 Business East to Exit 216 Patterson Street. Continue straight ahead for 2.4 miles to the Coliseum Complex. *Continue 5 miles on I-40 Business East to Exit 217 Gate City Blvd. (formerly High Point Rd.). Turn left at top of ramp and continue 1 mile on Gate City Blvd. (formerly High Point Rd.) to Ellington St. Turn right for .5 mile and enter Complex through main entrance.

HIGHWAY 220 NORTH FROM ASHEBORO: Highway 220 North to Greensboro turns onto Freeman Mill Rd. Stay on Freeman Mill Rd. After crossing I-85 Business, proceed 1.8 miles and turn left onto Coliseum Blvd. 1 mile to the Complex on your left, turn left onto Ellington St. and right into the main entrance.

HIGHWAY 220 SOUTH FROM VIRGINIA: Coming South on Highway 220 keep left to continue on I-73 South. Take exit toward Winston-Salem. Take Exit 1 for I-40/US 421 toward Greensboro/Winston-Salem. Keep left to I-40 East. Take Exit 216 Greensboro/Coliseum Area. Continue on Patterson St. then turn left onto W. Gate City Blvd.
